ORDER GRANTING STAY WITH MODIFICATION

On September 14, 2006, the Board of Nursing considered the petitioner's request for a three month stay of the suspension of her nursing license and a decrease in her random drug screens. Based upon all information of record showing that the petitioner has been in compliance with the terms and conditions of her original Board order dated July 11, 2002, the Board now finds and orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a three month stay of suspension of the limited license of Mary Beth Kramer (Lic. #21417) to practice as a licensed practical nurse is hereby GRANTED.

IT FURTHER ORDERED that the petitioner's request for a modification of her drug screens is GRANTED and shall be reduced to fourteen (14) per year.

This Order is effective upon the date of signing and is continuous from the previous stay.
