On June 8, 2006, the Wisconsin Board of Nursing considered the request of the petitioner for a three month stay of the suspension, pursuant to the Order dated September 5, 2002. Petitioner also requested a decrease in his drug screens. Based upon all information of record herein, showing that the petitioner is in compliance with the terms and conditions of his limited license, the Board finds and orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a three month stay of the suspension of the limited license of ROBERT O. SAESS, R.N., (lic. #134724) to practice as a RN in the state of Wisconsin is hereby GRANTED. IT IS FURTHER ORDERED that the request for a modification in his drug screens is GRANTED. Petitioner's screens shall be reduced to 14 per year.

This Order is effective upon the date of signing and is continuous from the date of the previous stay.
