On the basis of the verified Petition for Summary Suspension and testimony of Celina Kobs, investigator for the Division of Enforcement, at the meeting of the Wisconsin Dentistry Examining Board on January 18, 2006, the Board finds:

1. That Notice of the Petition for Summary Suspension was served on Respondent by mailing a copy of the Notice and Petition to Theodore Taylor, DDS, at 130 Dauphin Street, Green Bay, Wisconsin 54301 on January 17, 2006, and by fax transmission to 920/469-7542, and by telephone to 920/469-7461, and to the receptionist at Respondent's office location by fax transmission to 920/406-0621.
2. That there is probable cause to believe that Respondent has intentionally failed to comply with universal infection control precautions in his practice of dentistry, and that he maintains his operatory in a fashion incompatible with compliance with universal infection control precautions.
3. That Respondent's conduct with regard to universal infection control precautions imperatively requires the emergency suspension of Respondent's license to protect the public health, safety and welfare.

NOW, THEREFORE, pursuant to Wis. Stat. s. 447.07 and Wis. Admin. Code ch. RL 6, the license previously granted to Theodore Taylor, D.D.S., is SUMMARILY SUSPENDED, effective immediately.

IT IS FURTHER ORDERED that the suspension shall continue in effect until the effective date of a final order and decision in the disciplinary proceedings against Respondent, unless otherwise ordered by the Dentistry Examining Board or the Administrative Law Judge of the Department of Regulation and Licensing assigned to hear the disciplinary proceedings on behalf of the Dentistry Examining Board.

RESPONDENT IS HEREBY NOTIFIED that he has the right to demand a hearing to show cause why the summary suspension should not be continued; that hearing to be held within twenty days of receipt of Respondent's request for a hearing, unless a later time is requested by or agreed to by Respondent.
