PROCEDURAL HISTORY

On July 12, 2006, the State of Wisconsin Dentistry Examining Board reviewed the petition by Larry Nillissen, DDS, for modification of the limitations in effect against his license, pursuant to the Board's Final Decision and Order dated November 6, 2002.

FINDINGS OF FACT

1. Larry Nillissen, D.D.S., Respondent, date of birth October 3, 1956, is licensed by the Wisconsin Dentistry Examining Board as a dentist in the state of Wisconsin pursuant to license number 15-2723, which was first granted June 17, 1981.
2. Dr. Nillissen's last address reported to the Department of Regulation and Licensing is: P.O. Box 206, 409A Main Street, Birnamwood, WI 54414.
3. On July 12, 2006, the Board considered Dr. Nillissen's petition for modification of the terms and conditions imposed against his license. More specifically, Dr. Nillissen asked for modification of the prohibition in effect restricting his practice from providing dental care to all patients under 18 years old.

CONCLUSIONS OF LAW

The Dentistry Examining Board has jurisdiction and authority in this matter, pursuant to Wis. Stat. § 447.06.

ORDER

Based upon the Board's review, IT IS HEREBY ORDERED that the petition for modification by Larry Nillissen, DDS. is DENIED.

Dr. Nillissen failed to provide sufficient information to evaluate his petition. If Dr. Nillissen chooses to repetition, any future petition by Dr. Nillissen should include a current independent sexual boundaries and psychiatric evaluation from a mental health care provider pre-approved by the Wisconsin Dentistry Examining Board designee or liaison. Dr. Nillissen should submit potential evaluators to the Department Monitor for board liaison approval.
