On January 26, 2006, the Wisconsin Board of Nursing considered information concerning petitioner's non-compliance with her Board order dated October 3, 2003. The information showed petitioner to be non-compliant with her drug screens. Based upon the information of record herein, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the stay of the suspension of the license of RENEE L. BACON (lic#104769) to practice as a registered nurse in Wisconsin is hereby DENIED.

IT IS FURTHER ORDERED that pursuant to the terms of her order, petitioner shall not request a further stay until she has proof of compliance with the conditions and limitations during the prior three month period.

This Order is effective upon five (5) days of the date of signing.
