On June 8, 2006, the Wisconsin Board of Nursing reviewed the petitioner's request for full reinstatement or stay of suspension, pursuant to her board order dated October 3, 2003. The information showed petitioner to be non-compliant with the drug screen call-in procedure for the second time. Based upon the information of record herein, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for full reinstatement or stay of the suspension of the license of RENE L. BACON (lic#104769) to practice as a registered nurse in Wisconsin is hereby DENIED.

IT IS FURTHER ORDERED that pursuant to the terms of her order, the frequency of petitioner's drug screens shall be increased to one time per week. Petitioner shall not request a further stay until she has proof of compliance with the terms of her order for three months.
