On November 16, 2006, the Board of Nursing considered the petitioner's request for a three months stay of the suspension of her nursing license and for a decrease in her drug screens. Based upon all information of record herein, showing that the petitioner has been in compliance with terms and conditions of her Board order dated January 10, 2003, and the decrease in her drug screens is supported by her therapist, the Board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a three month stay of suspension of the license of ELLEN N. LALUZERNE, (lic. # 114082) to practice as a registered nurse in the state of Wisconsin is hereby GRANTED.

IT IS FURTHER ORDERED that the petitioner's drug screens shall be decreased to 26 times per year.
