On March 9, 2006, the Board of Nursing reviewed information from petitioner's attorney indicating that petitioner voluntarily surrenders her registered nursing license due to health issues which prevent her from working. The petitioner's license had been suspended and limited for a period of five years due to her diversion of controlled substances from her workplace and her diagnosis of opioid dependence, pursuant to the Board order dated February 7, 2003.
