On June 8, 2006, the Wisconsin Board of Nursing reviewed the petitioner's request for a three month stay of suspension, pursuant to his Board order dated December 5, 2003. The petitioner also requested a reduction in his drug screens. The petitioner's therapist supports the reduction in therapy session to quarterly. Based upon all information of record herein, the Board now finds and orders as follows:

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the request for a three month stay of the suspension of the license of RICHARD D. MUNSTER, to practice as a registered nurse (#77189) is hereby GRANTED.

IT IS FURTHER ORDERED that the petitioner's request for reduction in his drug screens is DENIED.

IT IS FURTHER ORDERED that petitioner's therapy shall be reduced to one session per quarter.

This Order is effective upon the date of signing and is continuous from the date of the previous stay.
