On June 8, 2006, the Wisconsin Board of Nursing reviewed the petitioner's request for reinstatement of a stay of suspension, pursuant to her Board order dated March 4, 2004. The information showed petitioner to be compliant with the requirements of her order. Based upon the information of record herein, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that reinstatement of a three month stay of the suspension of the license of MADGE M. KRUEGER (lic#105822) to practice as a registered nurse in the state of Wisconsin is hereby GRANTED.

IT IS FURTHER ORDERED that the length of petitioner's order shall be increased by three months due to her suspension on March 4, 2006, for non-compliance.
