On October 12, 2006, the Wisconsin Board of Nursing reviewed the petitioner's request for reinstatement of her nursing license. The information of record shows that petitioner surrendered her license in 2004 and was reinstated in June 2006, subject to a indefinite suspension. Based upon the information of record showing that the petitioner has been compliant with the terms and conditions of her disciplinary order, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the petitioner shall be granted a LIMITED license for the sole purpose of taking a Board-approved nurse refresher course.

IT IS FURTHER ORDERED that petitioner shall not have access to controlled substances during the clinical portion of her refresher course, and she shall provide a copy of the June 2006 order to the facility where she performs her clinical coursework. Upon successful completion of the nurse refresher course, the petitioner may apply for reinstatement of her LPN license.
