ORDER DENYING REINSTATEMENT OF LICENSE

On July 13, 2006, the Wisconsin Board of Nursing reviewed the petitioner's request for reinstatement of her registered nursing license pursuant to the board order dated March 10, 2005. The information of record shows that petitioner has not submitted proof that she has successfully passed her rehabilitation review by the Department of Health and Family Services. Based upon the information of record herein, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for reinstatement of the license of SHELLEY L. HOLMES (lic#130659) to practice as a registered nurse in Wisconsin is hereby DENIED.

IT IS FURTHER ordered that pursuant to this notification of a caregiver violation, the petitioner is not eligible to work in a DHFS facility, which would include her current place of employment, until she passes her rehabilitation review. Petitioner should contact Nancy Nelson at DHFS (608) 266-5602 to obtain a rehabilitation review application.

IT IS FURTHER ORDERED that upon passage of the rehabilitation review, the petitioner may reapply to the Board of Nursing for reinstatement of her license, however, reinstatement is subject to the discretion of the Board based upon all of the circumstances. This Order is effective upon the date signed below.
