On March 22, 2006, the State of Wisconsin Psychology Examining Board reviewed the documentation presented in support of the request by Kathleen M. Roblee, PHD, for modification of conditions, and for approval of clinical supervisor as provided in the Board's Final Decision and Order dated May 5, 2004.

Based upon the Board's review;

IT IS HEREBY ORDERED that the practice limitations requiring the presence of another licensed or certified therapist or counselor for provision of psychotherapy or client counseling is removed for the following settings;

- 1. When involved in family or group therapy.
- 2. For a caseload of no more than three individuals.

IT IS FURTHER ORDERED that the request for approval of Dr. Mark Marnocha as the respondent's clinical psychologist supervisor is GRANTED.

All other restrictions and requirements of the original Final Decision and Order remain in full force and effect.
