On June 8, 2006, the Wisconsin Board of Nursing reviewed the petitioner's request for a three month stay of suspension, pursuant to her Board order dated July 29, 2004. Petitioner also requested reduction in her therapy and drug screens. Based upon all information of record herein, the Board now finds and orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a three month stay of the suspension of the license of SANDRA R. OLSON, to practice as a registered nurse (#119811) is hereby GRANTED.

IT IS FURTHER ORDERED that the petitioner's request for reduction in her drug screens is GRANTED. The frequency of petitioner's screens shall be reduced to 42 times per year.

IT IS FURTHER ORDERED that petitioner's therapy shall be reduced to one session per month.

This Order is effective upon the date of signing and is continuous from the date of the previous stay.
