On July 13, 2006, the Wisconsin Board of Nursing reviewed the petitioner's request for reinstatement of her registered nursing license and advance practice nurse prescriber certificate, pursuant to the Board order dated December 9, 2004. The information of record shows that petitioner has not satisfied the terms and conditions of her Board order which required continuing education, payment of costs and proof of rehabilitation and fitness to practice. Based upon the information of record herein, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for reinstatement of the registered license of MARY LYNN KUSIK (#63519) in Wisconsin is hereby DENIED.

IT IS FURTHER ORDERED that petitioner must pay her costs, complete the required continuing education, enter into a 5 year standard impairment order and submit a current alcohol and drug (AODA) assessment, and upon successfully meeting all of the requirements, the petitioner may re-apply for a limited license to take a Board-approved nurse refresher course.
