On October 12, 2006, the Board of Nursing considered the petitioner's request for reinstatement of her nursing registered nurse license (#74093), and stay of suspension, pursuant to the Board Order dated April 25, 2005. Based upon all information of record herein showing petitioner's compliance with her Board order, the Board of Nursing makes the following:

ORDER

IT IS ORDERED that the request for reinstatement of the nursing license of Cindy L. Wierichs, R.N. (lic. #74093) and three month stay of suspension is hereby GRANTED.

IT IS FURTHER ORDERED that the five-year period of the petitioner's license limitations shall be restarted, effective October 12, 2006, due to the prior violations of her Board order.

This order is effective as of October 20, 2006.
