On September 29, 2005, the Dental Examining Board issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent was required to complete 6 hours of continuing dental education approved by the Board in the topic of pediatric dentistry, and by the condition that he satisfactorily complete 6 hours of continuing dental education approved by the Board in the topic of restorative dentistry including preparing teeth to receive and placing amalgam restorations within nine months from the date of the board order (September 29, 2005).

On July 12, 2006, the board considered evidence that Dale Falk has not completed the continuing education requirement within the agreed nine months. The board order dated September 29, 2005, states that if respondent fails to complete the continuing education requirement then his license shall be suspended without further hearing or notice.

NOW, THEREFORE, IT IS ORDERED that the license of DALE FALK DDS, shall be suspended effective July 17, 2006, and remain in suspended status until successful completion of an approved continuing education program and proof of completion has been received by the Department of Regulation and Licensing monitor.
