#### PROCEDURAL HISTORY

On September 6, 2006, the State of Wisconsin Dentistry Examining Board reviewed the petition by Dale P. Falk, DDS, for restoration of full licensure, pursuant to his completion of the requirements set forth in the Board's Final Decision and Order dated September 29, 2005:

### **FINDINGS OF FACT**

- 1. Dale P. Falk, D.D.S, (DOB 3/17/1954) is duly licensed to practice dentistry in the state of Wisconsin (license # 15-2284). This license was first granted on 6/19/1979. Dr. Falk's most recent address on file with the Wisconsin Dentistry Examining Board is W175 Highway 18, Sullivan, Wisconsin 53178.
- 2. On September 29, 2005, the Dentistry Examining Board imposed discipline upon the license to practice dentistry of Dr. Falk.
- 3. On September 6, 2006, .the Board considered Falk's petition for return to full and unrestricted licensure, pursuant to his completion of all terms and conditions imposed against his license.

#### CONCLUSIONS OF LAW

The Dentistry Examining Board has jurisdiction and authority in this matter, pursuant to Wis. Stat. § 447.06.

## ORDER

Based upon the Board's review, IT IS HEREBY ORDERED that the license of Dale P. Falk, DDS., to practice dentistry in the State of Wisconsin is hereby restored to full and unrestricted status.
