On April 20, 2006, the Wisconsin Board of Nursing considered the request of the petitioner for a further three month stay of the suspension of her nursing license and for modifications in her therapy and urine drug screens. Based upon all information of record herein, showing that petitioner is in compliance with the terms and conditions of her limited license and has therapist support for the requested modifications, the Board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a three month stay of the suspension of the registered nurse license of JENELLE M. DEBYLE, R.N. (lic. #125986) in the state of Wisconsin is hereby GRANTED.

IT IS FURTHER ORDERED that the petitioner's request for a reduction in her therapy sessions to two (2) times per month and a reduction in her random urine drug screens to forty-two (42) times per year is GRANTED. However, all drug screens must be observed.

This Order is effective upon signing and the stay is continuous from the date of the previous stay.
