On December 14, 2006, the Wisconsin Board of Nursing reviewed information submitted by the Petitioner in compliance with Board's prior order granting a one month stay of suspension. The information of record showed that Petitioner has arranged for an AODA assessment from an approved provider and has submitted the results of recent drug screen (hair specimen), which was negative. Based upon all of the information of record, the Board of Nursing now finds and makes the following:

### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the stay of suspension of the nursing license of DONALD C. ROSS, R.N., (lic.# 97923) to practice as a registered nurse in the state of Wisconsin is hereby GRANTED and continued for an additional period of thirty (30) days.

IT IS FURTHER ORDERED that the Board is next scheduled to meet on January 25, 2007, and will review any request for a further stay of suspension and the AODA evaluation, if available to determine if a further stay of suspension is appropriate. This Order is effective upon the date signed below.
