On November 16, 2006, the Board of Nursing considered the petitioner's request for a stay of suspension and modification of her Board order dated January 27, 2005. The petitioner requested modification to allow her access to dispense narcotics at her workplace and a reduction in therapy. Based upon all information of record herein, including information showing that petitioner is in compliance with the terms and conditions of her order, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that a further three month stay of suspension of the nursing license of Vicki L. McCaulley, R.N. (lic.#114158), is hereby GRANTED.

IT IS FURTHER ORDERED that the petitioner's request for modification of her Board order to allow her access to narcotics at her workplace is GRANTED.

IT IS FURTHER ORDERED that petitioner's therapy session shall be reduced to bi-monthly but the frequency of her drug screens shall not be decreased.
