On July 13, 2006, the Board of Nursing considered the petitioner's request for reinstatement of her registered nurse license (#114158) and stay of suspension, pursuant to the Board order dated January 27, 2005. The petitioner also requested a reduction in her urine screens and counseling sessions. Based upon all information of record herein, including information showing that petitioner is in compliance with the terms and conditions of her order, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for reinstatement of the limited license of Vicki L. McCaulley, R.N. (#114158), to practice as a registered nurse is hereby GRANTED.

IT IS FURTHER ORDERED that the petitioner's request for modifications to her board order for urine screens and counseling are DENIED.
