The Veterinary Examining Board considered this matter at its meeting on May 24, 2006.

BACKGROUND

On May 25, 2005, the Veterinary Examining Board issued its Final Decision and Order in the above-captioned matter, adopting the Stipulation signed by the parties. Under the Board Order, Dr. Thebert's license to practice veterinary medicine was limited and he was required to comply with certain terms and conditions.

On or about February 17, 2006, Dr. Thebert submitted a letter to the Board requesting that the restrictions on his license be removed. On May 24, 2006, the Board considered Dr. Thebert's request for removal of the limitations on his license. Based upon all information of record, including information provided by Dr. Thebert at the Board meeting, the Board orders the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the conditions and limitations placed on the license (#2915) of Jacques R. Thebert, DVM, to practice veterinary medicine in the state of Wisconsin be, and hereby are, removed and that he be granted full licensure.

This order is effective on the date it is signed by a designee of the Board.
