~~This matter was commenced by the filing of a Notice of Hearing and Complaint on September 21, 2005. Dr. Shim filed an Answer to the Complaint on September 28, 2005. Pursuant to the Scheduling Order issued by the Administrative Law Judge on October 11, 2005, the hearing in this matter was scheduled for January 9-13, 2006.~~

On December 14, 2005, the Medical Examining Board issued an Order of Summary Suspension in which it ordered that Dr. Shim's license to practice medicine and surgery be suspended for 30 days, and that an Amended Complaint be filed. On December 14, 2005, the Division of Enforcement filed its Amended Complaint.

On December 21, 2005, Dr. Shim, by Attorney Patrick J. Knight and Attorney Paul R. Erickson, filed a motion to reschedule the hearing that was set for January 9-13, 2006. The Division of Enforcement, by Attorney Arthur Thexton and Attorney Gilbert Lubcke, submitted its response to Dr. Shim's motion on December 22, 2005. The Division stated in its response that it was prepared and ready to proceed to hearing. A telephone pre-hearing conference was held on January 3, 2006, at which time, Dr. Shim's motion was scheduled for further consideration at the hearing on January 9, 2006. On January 9, 2006, the hearing in this matter commenced as scheduled, at which time, the Administrative Law Judge granted Dr. Shim's motion to adjourn the hearing until April 3-7, 2006.

Based upon the record herein, the Administrative Law Judge makes the following Findings of Fact, Conclusions of Law and Order.

**FINDINGS OF FACT**

1. The Administrative Law Judge adopts the Findings of Fact contained in the Order of Summary Suspension issued by the Medical Examining Board, dated December 14, 2005, which is attached hereto and incorporated by reference herein.

2. By requesting an adjournment of the hearing scheduled for January 9-13, 2006, Dr. Shim caused a delay in the hearing process.

3. Dr. Shim does not object to the suspension of his license to practice medicine and surgery until the issuance of a Final Decision and Order in this matter by the Medical Examining Board.

4. Dr. Shim consents to the service on this Order on his attorneys of record by certified mail.

**CONCLUSIONS OF LAW**

1. The legal requirements for summary suspension pursuant to Wis. Stats., § 448.02 (4), have been met.

**ORDER**

**NOW THEREFORE, IT IS ORDERED**, that the license (#34797) of Jae Y. Shim, M.D., to practice medicine and surgery in the State of Wisconsin is suspended until the issuance of a Final Decision and Order in this matter by the Medical Examining Board.
