PROCEDURAL HISTORY

A formal disciplinary proceeding was filed against Stephen G. Fleck before the Psychology Examining Board on November 3, 2005. On November 18, 2005, the Department of Regulation and Licensing received a letter from Stephen G. Fleck tendering the surrender of his license to practice psychology.

The Psychology Examining Board makes the following

FINDINGS OF FACT

1. Stephen G. Fleck, Ph.D. was licensed to practice psychology in the state of Wisconsin on November 18, 2003 (license # 2491.)
2. Dr. Fleck is the subject of a pending formal disciplinary proceeding before the Board, following his conviction on criminal charges of violating a harassment restraining order, carrying a concealed weapon, and resisting an officer.
3. Dr. Fleck has tendered the surrender of his license to practice psychology.

CONCLUSION OF LAW

1. The Psychology Examining Board has jurisdiction in this matter pursuant to Wis. Stat. ch. 455.

ORDER

Now, therefore, the Psychology Examining Board accepts the surrender of the license previously granted to Stephen G. Fleck.

IT IS FURTHER ORDERED that all disciplinary proceedings pending against Stephen G. Fleck before the Psychology Examining Board are dismissed as moot.
