The parties in these matters agree to the terms and conditions of the attached Stipulation as the final decision of the matter(s), subject to the approval of the Funeral Directors Examining Board (Board). The Board has reviewed the Stipulation agreement annexed to this Final Decision and Order, and considers it acceptable. Accordingly, the Board adopts the attached Stipulation and makes the following:

#### **FINDINGS OF FACT**

- 1. Respondent Daniel G. Duffenbach ("Respondent"), whose date of birth is November 16, 1953, whose last known address of record with the Department of Regulation and Licensing ("Department") is 420 Bay Street, Chippewa Falls, WI 54729, holds a license as a Funeral Director (#77-4279). Respondent was granted the license on June 30, 1977, pursuant to Wis. Stat. ch. 445, and has held it at all times material to this complaint. The license will expire, or did expire, on December 31, 2005.
- 2. On May 25, 2004, Respondent was convicted of homicide by Negligent Operation of a Motor Vehicle (Chippewa County Case No. 2003CF223) and Operating with a Prohibited Alcohol Content of .08 or More (3<sup>rd</sup> Offense). The facts underlying the conviction are that Respondent lost control of a vehicle that he was driving, causing the death of a passenger. At the time of the accident Respondent was found to have a .203 blood alcohol content.
- 3. Respondent's convictions substantially relate to the practice of funeral directing because in most practice settings funeral directors are on-call 24 hours per day to transport the remains of decedents. Under most circumstances it can reasonably be expected that there will be times when Respondent is called upon to operate a motor vehicle with little or no notice. Respondent's conviction of a 3<sup>rd</sup> incident of operating a motor vehicle with a prohibited alcohol content demonstrates an inability to refrain from operating a motor vehicle while impaired by alcohol.
- 4. Per Wis. Admin. Code § FD 3.02 it is unprofessional conduct for any licensee or owner of a licensed funeral establishment to:
  - (1) Violat(e)... any state or federal law substantially related to the practice of funeral directing.

#### **CONCLUSIONS OF LAW**

- 1. The Wisconsin Funeral Directors Examining Board has jurisdiction to act in these matters pursuant to Wis. Stat. § 445.13.
- 2. The Wisconsin Funeral Directors Examining Board has authority to enter into this stipulated resolution of this matter pursuant to Wis. Stat. § 227.44(5).

3. Respondent Daniel G. Duffenbach by his conduct as described in paragraphs 2-3 above, did commit one or more violations of Wis. Admin. Code § FD 3.02(1).

#### **ORDER**

#### NOW, THEREFORE, IT IS HEREBY ORDERED:

- 1. That if DANIEL G. DUFFENBACH at any time renews his licenses to practice as a Funeral Director in the State of Wisconsin, then the license issued to him shall be, and hereby is, LIMITED. Specifically, Daniel G. Duffenbach may only practice under the supervision of another licensed funeral director is good standing, or the owner of a licensed funeral hom in good standing. The name of the supervising funeral director or owner shall be submitted to the Department of Regulation and Licensing, Department Monitor, at the address below. The supervising funeral director or owner shall be responsible for ensuring that Respondent is not under the influence of alcohol while operating any motor vehicle in the course of practicing as a funeral director. Respondent may petition the Board for removal of this limitation following the successful completion of AODA counseling and treatment, as required by 2003CF223, and following all periods of confinement, probation or parole, as called for by 2003CF223.
- 2. Respondent shall, within one hundred and twenty (120) days of the date of this Order, pay to the Department of Regulation and Licensing partial costs of this proceeding in the amount of \$50.00, pursuant to Wis. Stat. § 440.22(2).
- 3. All payments and information required by this Order, and any request for removal of the limitation shall be mailed, faxed or delivered to:
