On April 27, 2006, the State of Wisconsin Chiropractic Examining Board heard the testimony of Dr. Reek, received the arguments of counsel Kevin Milliken and reviewed the documentation presented in support of the request by Laroy D. Reek, D.C., for termination of the suspension and modification of the Decision as provided in the Board's Final Decision and Order dated February 23, 2006.

Based upon the Board's review;

IT IS HEREBY ORDERED that the suspension of Respondent Laroy D. Reek's license to practice chiropractic in the State of Wisconsin will be stayed upon proof of compliance with the following conditions being submitted to the Department Monitor and subject to the following limitations:

- 1. Respondent shall locate an appropriate mental health professional, approved by the Department Monitor, and initiate an evaluation and possible treatment plan for his anxiety. The respondent shall provide appropriate releases to allow the mental health professional to inform the Board, through the Monitor, of the results of the evaluation, the terms of any treatment plan proposed and reports of the respondent's compliance and progress in the treatment plan.
- 2. Respondent shall provide satisfactory evidence of the passage of the NBCE special purpose examination in chiropractic.
- 3. The stay of suspension would continue provided the respondent complies with the following conditions and limitations;
  - a. respondent's colleague, Dr. John Haase, or another chiropractor acceptable to the Board, agree to monitor respondent in his practice of chiropractic;
  - b. respondent shall sign consent forms allowing the Department and its employees to communicate with Dr. Haase, or any other monitoring chiropractor, regarding his practice;
  - c. Dr. Haase shall submit weekly reports to the Department Monitor in which he evaluates Dr. Reek's competence in practice and the quality of his performance of the tasks and duties of chiropractic practice;
  - d. in the event that Dr. Haase's report identifies any deficiencies in practice that pose a material risk to patient safety, the stay shall be immediately revoked. The board delegates the authority to revoke the stay to the Department Monitor.
- 4. The respondent has the right to seek board review of any action taken by the Department Monitor;
- 5. At the June 22, 2006 meeting of the Chiropractic Examining Board, or anytime thereafter, the respondent has the right to seek further modifications of this order, including but not limited to a termination of the suspension or a reduction in the frequency of work reports.
