On December 14, 2006, the Wisconsin Board of Nursing considered the request of the Petitioner for an initial stay of the suspension of her nursing licenses, (registered nurse and advance practice nurse prescriber) pursuant to the Board Order dated March 9, 2006. Based upon the information of record showing that Petitioner is in compliance with her Board order requirements and has provided a letter of support from her health care provider, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for an initial three month stay of the suspension of the license of JULIE A. WNUK, R.N., to practice as a registered nurse (lic. # 30-108442) in the state of Wisconsin is hereby GRANTED. IT FURTHER ORDERED that the additional limitations and requirements shall be placed upon Petitioner's registered nurse license:

1. Petitioner must remain compliant and continue with her psychotherapy or other mental health treatment as determined by her psychiatrist, and such treatment shall include not less than two (2) therapy sessions per month for the first year;
2. Petitioner shall comply with random drug screens at a frequency of fifty-six (56) screens per year. The Petitioner's screening procedure shall include a testing interval of two (2) hours from the time of notification and a standard screen panel to include Fentanyl. In addition, the Petitioner's drug screen panels shall also include, on a random basis, testing for the controlled substances Propofol;
3. Petitioner shall not have access to controlled substances at her workplace;
4. Petitioner may not practice as an advance nurse prescriber or certified registered nurse anesthetist unless approved by the Board.
5. Petitioner must submit a petition for granting of additional stays based upon her compliance with the terms and conditions of this order.
6. Petitioner must completed eight (8) months of satisfactory compliance with this order prior to requesting approval of the Board to reinstate her APNP license or to resume advance practice. If the Board approves the Petitioner's advance practice and reinstates her APNP license, the petitioner's drug screen frequency shall increase to one hundred six (106) times per year.

IT IS FURTHER ORDERD that all terms and conditions of the Petitioner's original Board order dated March 9, 2006, not inconsistent with or superseded by the additional limitations ordered herein, shall remain in full force and effect. Violation of any terms of this order or the original order may be construed as conduct imperiling public health, safety and welfare and may result in immediate removal of the stay, without further notice or hearing, and commencement of further disciplinary procedures.

This Order is effective upon the date of signing and the stay is continuous contingent upon the petitioner's compliance with the terms and conditions of her Board order.
