### PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board of Nursing. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

#### **FINDINGS OF FACT**

- 1. Alexis A. Goldberger, L.P.N. (DOB 10/29/1977), is duly licensed as a practical nurse in the state of Wisconsin (license #31-34788). This license was first granted on July 29, 1998.
- 2. Respondent's most recent address on file with the Wisconsin Board of Nursing is 2271 County Road C, Stevens Point, WI 54481.
- 3. At all times relevant to this action, Respondent was working as a licensed practical nurse at Weyauwega Health Care Center in Weyauwega, Wisconsin.
- 4. Beginning on May 1, 2003 and continuing through October 5, 2003, Respondent practiced without a valid Wisconsin licensed practical nurse credential.

#### **CONCLUSIONS OF LAW**

- 1. The Wisconsin Board of Nursing has jurisdiction to act in this matter, pursuant to Wis. Stat. § 441.07 and has authority to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).
  - 2. The conduct described in paragraph 4, above, constitutes a violation of Wis. Stat. § 441.10(3)(c).

#### **ORDER**

NOW, THEREFORE, IT IS HEREBY ORDERED that the license of Alexis A. Golderberger to practice as a practical nurse in the State of Wisconsin is hereby REPRIMANDED effective the date of signing of this Order.

#### IT IS FURTHER ORDERED that

- 1. Respondent shall, within 120 days of the date of this Order, pay to the Department of Regulation and Licensing costs of this proceeding in the amount of \$100.00 pursuant to Wis. Stat. § 440.22(2).

- 3. In the event that Respondent fails to pay costs as ordered, Respondent's license shall be SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of this Order.
