PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Georgia Knox Mode, M.D. (DOB 04/19/42), is duly licensed to practice medicine and surgery in the state of Wisconsin (license #20-25366). This license was first granted on July 1, 1983. Dr. Mode's specialty is family practice.
2. Respondent's latest address on file with the Department of Regulation and Licensing is N2861 Mode Lane, Fort Atkinson, WI 53538.
3. From October 31, 2003 and continuing through December 14, 2005, Respondent practiced without a current registration for her Wisconsin medicine and surgery license.
4. Respondent consents to the issuance of the following Conclusions of Law and Order in resolution of this matter.

CONCLUSIONS OF LAW

1. The Wisconsin Medical Examining Board has jurisdiction over this matter, pursuant to Wis. Stat. § 448.02(3) and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).

2. The conduct described above constitutes a violation of Wis. Stat. § Med 448.07(1).

ORDER

NOW, THEREFORE, IT IS ORDERED that the stipulation of the parties is approved.

IT IS FURTHER ORDERED that Georgia Knox Mode, M.D. is hereby REPRIMANDED.

IT IS FURHTER ORDERED that:

1. Respondent shall, within sixty (60) days from the date of this Order, pay costs of this proceeding in the amount of one hundred (\$100.00) dollars. Payment shall be made payable to the Wisconsin Department of Regulation and Licensing, and mailed to:

2. The pending investigation, 05 MED 466, shall be, and hereby is, closed without further proceedings.

3. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's certification or licensure pursuant to the procedures set forth in Wis. Admin. Code Ch. RL 6. The Board in its discretion may in the alternative impose additional conditions, terms, and limitations or other additional discipline for a violation of any of the terms of this Order.

4. In the event the Respondent fails to pay the forfeiture or the costs as ordered the Respondent's license SHALL BE SUSPENDED until the Respondent has complied with the terms of this Order.

This Order shall become effective upon the date of its signing.
