PROCEDURAL HISTORY

On April 5, 2002, Robert X. Williams, III, M.D. was issued an unrestricted license to practice medicine and surgery in the State of Wisconsin. On January 25, 2006, the Department of Regulation and Licensing received a letter from Robert X. Williams, III, M.D. acknowledging a drug relapse and tendering the surrender of his license to practice medicine and surgery in the State of Wisconsin.

The Wisconsin Medical Examining Board makes the following:

FINDINGS OF FACT

1. Robert X. Williams, III, M.D. (DOB 11/29/62) is duly licensed to practice medicine and surgery in the state of Wisconsin (license #20-44323). This license was first granted on April 5, 2002. Respondent's specialty is general medicine.
2. Respondent's most recent address on file with the Wisconsin Medical Examining Board is 5607 Golf Stream Row, Columbia, MD 21044.
3. On April 5, 2002, Dr. Williams was issued an unrestricted license to practice medicine and surgery in the State of Wisconsin.
4. On January 24, 2006, Dr. Williams was notified that a urinalysis conducted by the Maryland Board of Physicians tested positive for cocaine.
5. On January 25, 2006, Dr. Williams acknowledged a drug relapse and has tendered the surrender of his license to practice medicine and surgery in the State of Wisconsin.

CONCLUSIONS OF LAW

1. The Wisconsin Medical Examining Board has jurisdiction to act in this matter, pursuant to Wis. Stat. § 448.02(3).

ORDER

NOW, THEREFORE, the Medical Examining Board accepts the surrender of the license previously granted to Robert X. Williams, III.

This Order is effective on the date of its signing.
