PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. **Shawna L. Brandenburg** is licensed in the State of Wisconsin as a Barbering and Cosmetology Manager, license # 81 30317. This license was first granted to her on 12/21/04. The most recent address on file with the Department of Regulation and Licensing for Ms. Rosen is 3487 Pintail Dr., Janesville, WI 53546.
- 2. On June 28, 2005, an investigator from the Department of Regulation and Licensing performed an inspection at GS & Hair Designers. Gail F. Schiefelbein is licensed in the State of Wisconsin as a Barbering and Cosmetology Manager, and is the owner of GS & Hair Designers.
- 3. During the inspection Mr. Schiefelbein indicated that Ms. Brandenburg was renting a booth from him at GS & Hair Designers under the name of Snips & Tips with Shawna.
 - 4. Snips & Tips with Shawna was operating without a Barbering and Cosmetology Establishment license.
 - 5. Snips & Tips with Shawna was granted an establishment license on July 15, 2005.

CONCLUSIONS OF LAW

- 1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 454.15, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
 - 2. Respondent **Shawna L. Brandenburg** has violated:
 - a. Wis. Stat. § 454.08(1)(b), and Wis. Admin. Code §§ BC 2.04(1) and BC 3.02(2)(b) by operating a rental booth without an establishment license.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. Respondent **Shawna L. Brandenburg,** license # 81 30317, be, and hereby is, **REPRIMANDED.**

IT IS FURTHER ORDERED that:

- 2. Respondent shall pay COSTS in the amount of \$230.00 within 90 days of the date of this Order.
- 3. Respondent shall pay a FORFEITURE in the amount of \$500.00 within 90 days of the date of this Order.
- 4. A payment of \$365.00 is due within 90 days from the date of this Order.
- 5. A payment of \$365.00 is due within 180 days from the date of this Order.

- 6. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely submit any payment as ordered, then the Respondent's license SHALL BE SUSPENDED without further notice or hearing until Respondent has complied with the terms of this Order.
 - 7. This Order is effective on the date of its signing.

IT IS FURTHER ORDERED, that file, 04 BAC 089 is hereby closed.
