On September 20, 2006, the Medical Board reviewed the petitioner's request for reinstatement of his license and stay of suspension pursuant to his Board order dated April 19, 2006. The petitioner's Board order provides that his licensure may be reinstated and his suspension stayed upon proof that the Respondent can safely return to practice. Based upon all information of record, the petitioner has not shown that he has satisfied the requirement for reinstatement or stay of suspension. Accordingly, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for reinstatement and stay of suspension of the medical license of LAWRENCE F. REICH, MD, (lic.#20-19373) is hereby DENIED.

IT IS FURTHER ORDERED that prior to petitioning for a further stay of suspension, the petitioner shall submit additional information from his health care provider(s) as to the medical indication for the scheduled drugs which have been prescribed to him.
