PROCEDURAL HISTORY

On July 12, 2006, the State of Wisconsin Dentistry Examining Board reviewed the petition by Gretchen K. Evenson, DDS, for an extension of time to pay costs imposed by the Board's Final Decision and Order dated May 3, 2006.

FINDINGS OF FACT

1. On May 3, 2006, the Dentistry Examining Board imposed discipline upon the license to practice dentistry of Gretchen K. Evenson, DDS (DOB 11/21/1951). Dr. Evenson's address of record with the Department of Regulation and Licensing is 100 West Walnut Street, Apt. 212B, Green Bay, WI 54303.
2. On July 12, 2006, the Board considered Evenson's petition for an extension of the due date for the payment of costs imposed by its May 3, 2006 Order.

CONCLUSIONS OF LAW

The Dentistry Examining Board has jurisdiction and authority in this matter, pursuant to Wis. Stat. § 447.06.

ORDER

Based upon the Board's review, IT IS HEREBY ORDERED that:

IT IS HEREBY ORDERED that Gretchen K. Evenson DDS, that the due date for the payment of costs in these proceedings is extended as follows:

Dr. Evenson shall make monthly payments of \$300 per month, commencing in October, 2006 on a schedule as determined by the Department Monitor. Payments shall continue until payment in full of costs assessed.

All other requirements of the original Final Decision and Order remain in full force and effect.
