## **PROCEDURAL HISTORY**

Following the denial of his application for a real estate appraiser credential, Bradley A. Perrin requested a hearing in the above-captioned matter. Thereafter, the parties attempted to reach a stipulated agreement. As a result of those negotiations, Mr. Perrin decided to withdraw his request for a hearing and will instead reapply for the credential. The Division of Enforcement had no objection to his request.

## **FINDINGS OF FACT**

- 1. Bradley A. Perrin (dob 10/26/65) applied for a certified residential appraiser license on or about August 19, 2005. His most recent address on file with the Department Regulation and Licensing is 820 210<sup>th</sup> Avenue in Somerset, Wisconsin.
- 2. The Department of Regulation and Licensing (Department) denied his application on April 7, 2006. The Department determined that two of Mr. Perrin's appraisals that were submitted with his application did not meet the USPAP standards
- 3. Following the denial of his application, Mr. Perrin filed a timely request for a hearing.

## **CONCLUSIONS OF LAW**

The Department of Regulation and Licensing has jurisdiction in this matter pursuant to § 458.03 (1), Wis. Stats.

## **ORDER**

NOW THEREFORE IT IS HEREBY ORDERED that this matter be DISMISSED.

## **OPINION**

Following the denial of his application for a real estate appraiser credential, Bradley A. Perrin requested a hearing in the above-captioned matter. Although the parties attempted to reach a stipulated agreement they were unable to do so. As a result, Mr. Perrin decided to withdraw his request for a hearing. He will likely reapply for the credential at a later date. Mr. Perrin's request is reasonable, and this matter should therefore be dismissed.
