PROCEDURAL HISTORY

On November 30, 2006, the State of Wisconsin Chiropractic Examining Board reviewed the petition by Stephen C. Misky, D.C., for restoration of full licensure, pursuant to his completion of the requirements set forth in the Board's Final Decision and Order dated August 3, 2006.

FINDINGS OF FACT

1. On August 3, 2006, the Board imposed discipline upon Stephen C. Misky's D.C., license to practice chiropractic.
2. On October 1, 2006, Stephen C. Misky, D.C., requested the full reinstatement of his license because he had completed all of the terms and conditions imposed against his license.
3. After review of Stephen C. Misky's, D.C., petition and the evidence submitted to the Board, the Board finds that Stephen C. Misky, D.C. has completed all of the terms and conditions imposed upon his license by the August 3, 2006, Board Order.

CONCLUSIONS OF LAW

The Chiropractic Examining Board has jurisdiction and authority in this matter, pursuant to Wis. Stat., s. 446.03.

ORDER

Based upon the Board's review, IT IS HEREBY ORDERED that the license of Stephen C. Misky, D.C., to practice Chiropractic in the State of Wisconsin is hereby restored to full and unrestricted status.
