PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Wisconsin Board of Nursing ("Board"). The Board has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Pauline Carter, (DOB April 21, 1943) is duly licensed as licensed practical nurse in the state of Wisconsin (license # 17430). This license was first granted on May 28, 1976.
- 2. Pauline Carter's most recent address on file with the Wisconsin Board of Nursing is 4637 North 18th Street, Milwaukee, Wisconsin 53209.
- 3. At all times relevant to this action, Pauline Carter was working as a licensed practical nurse at Eastside Rehabilitation Center, 2115 East Woodstock Place, Milwaukee, Wisconsin.
- 4. An informal complaint received by the Board of Nursing alleges on January 25, 2006, Pauline Carter was verbally abusive to a resident.

1. The Wisconsin Board of Nursing has jurisdiction to act in this matter, pursuant to Wis. Stat. §441.07, and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. §227.44(5).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. Pauline Carter, will, within nine (9) months of the date of this Final Decision And Order for Remedial Education, take and complete nine (9) credit hours of continuing education course in sensitivity training. Each course attended in satisfaction of this Order must be preapproved by the Board of Nursing or its designee. Pauline Carter will be responsible for locating courses satisfactory to the Board of Nursing and for obtaining the required approval of the courses from the Board of Nursing or its designee. Pauline Carter will within 60 days of completion of this educational requirement file an affidavit with the Board of Nursing stating under oath that she has attended in its entirety each of the courses approved for satisfaction of this requirement along with supporting documentation of attendance from the sponsoring organizations. This affidavit and the supporting documentation of attendance will be filed with:

All certifications, affidavits or other documents required to be filed with the Board of Nursing will be deemed filed upon receipt by the Department Monitor.

2. Pauline Carter will be responsible for paying the full cost of attendance at these courses.

IT IS FURTHER ORDERED that:

3. Pauline Carter shall, within sixty (60) days from the date of this Order, pay costs of this proceeding in the amount of one hundred thirty-five dollars and 85 cents (\$135.85). Payment shall be made payable to the Wisconsin Department of Regulation and Licensing, and mailed to:

- 4. In the event Pauline Carter fails to timely pay costs as ordered or fails to comply with the ordered continuing education Pauline Carter's license (#17430) SHALL BE SUSPENDED, without further notice or hearing, until Pauline Carter has complied with the terms of this Order. The Board or its designee will remove the suspension, if provided with sufficient information that Pauline Carter is in compliance with the Order and that it is inappropriate for the suspension to remain in effect. The Board in its discretion may impose additional conditions and limitations for a violation of any of the terms of this Order
 - 5. Pauline Carter is responsible for compliance with all of the terms and conditions of this Final Decision and Order.
 - 6. This Order is effective on the date of its signing.
