PROCEDURAL HISTORY

The Division of Enforcement filed a formal Complaint against Rosalie Zahn, R.N., on September 20, 2006. The matter was assigned to Administrative Law Judge Peggy E. Wichmann. On October 10, 2006, Ms. Zahn, through her attorney Theodore Skemp, agreed to resolve this matter without a contested hearing. No proceedings were held before the Administrative Law Judge.

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board of Nursing. The Board has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Rosalie Zahn, R.N., ("Respondent") was born on February 29, 1936, and is duly licensed as registered nurse in the state of Wisconsin pursuant to license number 56982. This license was first granted on November 3, 1972.
- 2. Respondent's most recent address on file with the Wisconsin Board of Nursing is 2653 Castle Place, LaCrosse, Wisconsin 54601.
 - 3. From October 2001 to November 2002, Respondent was working as a professional nurse as a private duty

nurse for Patient AP at his home, first in Racine, Wisconsin, and then in LaCrosse, Wisconsin.

- 4. After Patient AP terminated Respondent, Respondent continued to submit bills to Medicaid as if she were still providing services to Patient AP. Respondent was paid \$17,006.88 for services she did not provide to Patient A.P.
- 5. For this conduct, on March 7, 2006, in Dane County Circuit Court, Respondent was convicted of the crime of submitting fraudulent insurance claims, in violation of Wis. Stat. s. 943.395(1)(a) and (2)(a).

CONCLUSIONS OF LAW

- 1. The Wisconsin Board of Nursing has jurisdiction to act in this matter, pursuant to Wis. Stat. §441.07, and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).
- 2. The conduct described in paragraphs 3-5, above, constitutes a violation of Wisconsin Administrative Code § N 7.04(1) and (13).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. The license of Rosalie Zahn, R.N. to practice professional nursing in the State of Wisconsin, and her privilege to practice pursuant to the Multi-State Nursing Compact, is hereby REVOKED.

IT IS FURTHER ORDERED that:

2. This Order is effective on the date of its signing.
