The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Department. The Department has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Mose Macklin, Jr., (Date of Birth: May 16, 1962) is duly licensed as a Private Security Person in the state of Wisconsin (Permit #108-1282) by the Wisconsin Department of Regulation and Licensing. The permit was first issued on July 1, 1997. The permit expired on September 1, 2006. Mr. Macklin has the right to renew this permit upon payment of a late fee and the renewal credential fee pursuant to Wis. Stat. sec. 440.08(3). Mr. Macklin has not at this date submitted any renewal fees or late fees for renewal of his Private Security Person permit. Mr. Macklin's last address reported to the Department is 3314 North 46th Street, Milwaukee, Wisconsin 53216
- 2. On October 5, 2005, Mr. Macklin was convicted in Milwaukee Circuit Court of one count of felony 2nd Degree Recklessly Endangering Safety. A true and correct copy of the Criminal Complaint and Judgment of Conviction are attached as Exhibit A.
- 3. Mr. Macklin did not personally inform the Department of Regulation and Licensing of the October 5, 2005, felony conviction within 48 hours of conviction.
- 4. In resolution of this matter, Mose Macklin, Jr., consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Wisconsin Department of Regulation and Licensing is authorized to enter in the attached Stipulation pursuant to Wis. Stat. sec. 227.44(5).
- 2. Wis. Stat. sec. 440.26(4m)(b), and Wis. Admin. Code § RL 35.01(2), indicate that a license or permit holder who is

convicted of a felony or misdemeanor, or who is found to have committed a violation, in this state or elsewhere, shall notify the Department in writing of the date, place and nature of the conviction within 48 hours after the judgment of conviction.

- 3. Wis. Stat. sec. 440.26(6)(b) requires revocation of a Private Security Person Permit following a felony conviction.
- 4. Wis. Admin. Code § RL 35.01(2), indicates that the Department may limit, suspend, revoke or reprimand a credential holder who has violated any law, the circumstances of which substantially relate to the practice of a private security person.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that the Private Security Person Permit of Mose Macklin, Jr., (Permit #108-1282) is HEREBY REVOKED.

IT IS FURTHER ORDERED that Mose Macklin, Jr., shall pay the amount of SIX HUNDRED dollars (\$600.00) for a full assessment of costs of this proceeding, all to be paid within one hundred eighty (180) days of the effective date of the Board's Order adopting the Stipulated Agreement.

The assessed full assessment of costs shall be payable by cashier's check or money order made payable to the Department Monitor (Place case number on the check or money order and the words "Forfeiture" and/or "Costs").

It is hereby stipulated between Mose Macklin, Jr., and Claudia Berry Miran, attorney for the Department of Regulation and Licensing, Division of Enforcement, as follows:

- 1. This Stipulation is entered into as a result of a pending investigation of Mr. Macklin's licensure by the Division of Enforcement (05 RSG 034). Mr. Macklin consents to the resolution of this investigation by Stipulation and without the issuance of a formal complaint.
- 2. Mr. Macklin understands that by signing this Stipulation he voluntarily and knowingly waives his rights, including: the right to a hearing on the allegations against him, at which time the state has the burden of proving those allegations by a preponderance of the evidence; the right to confront and cross-examine the witnesses against him; the right to call witnesses on his behalf and to compel their attendance by subpoena; the right to testify himself; the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision; the right to petition for rehearing; and all other applicable rights afforded to him under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.
 - 3. Mr. Macklin has been provided the opportunity to obtain legal counsel prior to signing this Stipulation.
- 4. Mr. Macklin agrees to the adoption of the attached Final Decision and Order by the Department of Regulation and Licensing (Department). The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Mr. Macklin waives all rights to any appeal of the Department's order, if adopted in the form as attached.
- 5. If the terms of this Stipulation are not acceptable to the Department, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division of Enforcement for further proceedings. In the event that the Stipulation is not accepted by the Department, the parties agree not to contend that the Department has been prejudiced or biased in any manner by the consideration of this attempted resolution.
- 6. The parties to this Stipulation agree that the attorney or other agent for the Division of Enforcement may appear before the Department in open or closed session, without the presence of Mr. Macklin or Mr. Macklin's attorney, for purposes of speaking in support of this agreement and answering questions that the Department may have in connection with the Department's deliberations on the Stipulation.
- 7. Mr. Macklin is informed that should the Department adopt this Stipulation, the Department's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.
- 8. The Division of Enforcement joins Mose Macklin, Jr., in recommending the Department adopt this Stipulation and issue the attached Final Decision and Order.
