On November 22, 2006, the Wisconsin Department of Regulation and Licensing ("Department") granted Applicant a limited real estate salesperson license (#68968-94) in the state of Wisconsin. Pursuant to the Final Decision and Order ("Order") issued on the same date, Applicant may petition the Department for modifications of the limitations after two years from the date of the Order.

On February 20, 2020, the Wisconsin Real Estate Examining Board ("Board"), which has current jurisdiction in this matter, considered Applicant's request for a full, unrestricted license. Based upon the information of record, the Board finds and makes the following:
