PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Chiropractic Examining Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Erich G. Neumeyer, D.C., (DOB 08/21/1945) is duly licensed as a chiropractor in the state of Wisconsin (license #12-1284). This license was granted on 02/06/1973.
2. On or about May 18, 2006, Respondent was found guilty by the United States District Court for the Western District of Wisconsin on one count of Willfully Making and Subscribing a False Corporate Income Tax Return, a Class E felony, in United States v. Erich G. Neumeyer, United States District Court for the Western District of Wisconsin, No. 06-CR-027. A true and correct copy of the Information is attached as Exhibit A and a true and correct copy of the Judgment is attached as Exhibit B.
3. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

## CONCLUSIONS OF LAW

1. The Wisconsin Chiropractic Examining Board has jurisdiction to act in this matter, pursuant to Wis. Stat. § 446.03, and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).
2. The conduct described in paragraph 2, above, constitutes a violation of Wis. Admin. Codes § Chir 6.02(24) and § Chir 6.02(26).

## ORDER

NOW, THEREFORE, IT IS ORDERED that the license of Erich G. Neumeyer, D.C. (license #12-1284), to practice as a chiropractor in the State of Wisconsin is hereby suspended for an indefinite period.

1. Should Respondent wish to resume his practice as a chiropractor in the State of Wisconsin, he may petition the board for termination of the suspension, and he shall appear before the board in support of any such petition. At such time the Board may impose terms, conditions and limitations as it deems appropriate on a return to practice in the State of Wisconsin.

IT IS FURTHER ORDERED that:

2. Respondent shall, within ninety (90) days from the date of this Order, pay costs of this proceeding in the amount of two hundred fifty dollars (\$250.00). Payment shall be made payable to the Wisconsin Department of Regulation and Licensing, and mailed to:
