**PROCEDURAL HISTORY**

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

**FINDINGS OF FACT**

1. George Street Hair Company is duly licensed as a barbering and cosmetology establishment in the State of Wisconsin having license #080 0032011. This license was granted on 05/21/04.
2. George Street Hair Company's most recent address on file with the Department of Regulation and Licensing ("Department") is: 1907 George Street, LaCrosse, Wisconsin 54601. George Street Hair Company is owned by Gear Group LLC.
3. Vicki Schindler, date of birth: 05/28/47, is listed as a partner of Gear Group LLC and manager of record for George Street Hair Company. Department records indicate that Ms. Schindler holds a barbering and cosmetology manager's license, #81 12606. This license was first granted on 04/01/74.
4. Ms. Schindler's most recent address on file with the Department is: 1521 Wood Street, LaCrosse, Wisconsin 54603.

5. As a listed partner and manager of record at George Street Hair Company, Ms. Schindler was and is at all times relevant to this action responsible for compliance with Wisconsin Statutes, Chapter 454 and the Wisconsin Administrative Code for Barbering and Cosmetology Chapters 2 and 3.

6. On or about June 8, 2005, the Department received a complaint alleging that unlicensed booth renting was taking place at George Street Hair Company.

7. On or about April 5, 2006, a Department investigator conducted an inspection of George Street Hair Company. The inspection revealed that Ms. Jan M. Legler (#81 30504; granted: 05/05/05) was renting a barbering and cosmetology booth before obtaining an establishment license.

8. Department records indicate that Ms. Legler obtained an establishment license for her booth rental, George Street Hair Company (#80 33929) on or about April 19, 2006.

9. In resolution of this matter, Vicki Schindler and George Street Hair Company consent to the following Conclusions of Law and Order.

### **CONCLUSIONS OF LAW**

1. The Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 454.15.

2. The Barbering and Cosmetology Examining Board is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

3. Respondents Vicki Schindler and George Street Hair Company (#80 32011) have violated:

Wis. Stat. § 454.08 (1)(b) and Wis. Admin. Code §§ BC 2.04(1); 2.045(1) and 3.02(2)(b) by permitting an employee to rent a barbering and cosmetology booth without first obtaining a separate establishment license.

### **ORDER**

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is hereby accepted.

IT IS FURTHER ORDERED, that the Respondents are hereby **REPRIMANDED** for the violations set forth above.

IT IS FURTHER ORDERED, that the Respondents shall jointly and severally pay to the Department of Regulation and Licensing a forfeiture of **FIVE HUNDRED DOLLARS (\$500.00)**.

IT IS FURTHER ORDERED, that Respondents shall jointly and severally pay costs in this matter in the amount of **FIVE HUNDRED DOLLARS (\$500.00)**.

IT IS FURTHER ORDERED, that a down payment of **FIVE HUNDRED DOLLARS (\$500.00)** shall be submitted within thirty (30) days from the date of this order and one more payment of **FIVE HUNDRED DOLLARS (\$500.00)** will be due every sixty (60) days from the previous payment until the full **ONE THOUSAND DOLLARS (\$1,000.00)** is paid. Payments shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to:

IT IS FURTHER ORDERED, that in the event that Vicki Schindler and George Street Hair Company fail to timely submit payment of the forfeiture and costs as set forth above, the barbering and cosmetology manager's license for Vicki Schindler (#081 12606) and the establishment license for George Street Hair Company (# 080 32011) **SHALL BE SUSPENDED**, without further hearing and without further Order of the Board, and said suspension shall continue until the full amount of said costs has been paid to the Department of Regulation and Licensing and their failure to pay the costs shall be considered a violation of this Order by the Board.

IT IS FURTHER ORDERED, that file 05 BAC 046, be and hereby is, closed as to all Respondents.
