ORDER DENYING APPLICATION
FOR LICENSURE

On June 21, 2006, the Wisconsin Medical Examining Board considered the petitioner's application for a license to practice medicine and surgery. The petitioner previously held a medical license (lic. # 22943), which was disciplined by the Board on August 22, 1991, as a result of his chemical dependency and criminal conviction for sexual assault of a patient. The petitioner subsequently surrendered his medical license, pursuant to the order dated March 23, 1995, on the basis of his second criminal conviction for sexual assault of a patient. Based upon the information of record including the severity of the petitioner's prior misconduct and criminal convictions, the lack of documentation regarding the petitioner's current fitness to practice, and the lack of a current psychological and AODA assessment, the Board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the application for medical licensure of DANIEL F. CICHON, D.O., is hereby DENIED.
