On April 12, 2006, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by Charlene Willis, R.Ph., for a three-month extension of the stay of suspension of her license to practice pharmacy in the State of Wisconsin, as provided within the board's *Final Decision and Order* ("Order") dated October 10, 1995.

Requested by Willis was an increase in the number of hours to be worked unsupervised as a pharmacist in charge, currently at 32 hours per week, which was supported by her employer. Also requested by Willis was a reduction or elimination in individual or group therapy required by the *Order*, which was not supported by Willis' supervising physician or therapist.

Based upon the board's review:

IT IS HEREBY ORDERED that Charlene Willis, R.Ph., is granted a three-month stay of the suspension of license #11555 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED that the request for an increase in the number of hours to work unsupervised as a pharmacist in charge, currently at 32, is denied.

IT IS FURTHER ORDERED that the request to reduce or eliminate the individual or group therapy required by the *Order*, is denied.
