ORDER DENYING FULL REINSTATEMENT AND GRANTING STAY WITH MODIFICATIONS

On November 16, 2006, the Wisconsin Board of Nursing reconsidered the petitioner's request for full reinstatement of his nursing license or in the alternative a further stay of suspension and a decrease in his drug screens. Based upon the information presented which shows the petitioner has not completed five years of continuous active practice under the terms and conditions of his Board order dated April 12, 2002, the Board orders as follows:

<u>ORDER</u>

NOW, THEREFORE, IT IS ORDERED that the request for full reinstatement of the nursing license of RANDALL N. PROCKNOW, R.N. (lic. # 58624) is hereby DENIED.

IT IS FURTHER ORDERED that a three month stay of suspension is GRANTED.

IT IS FURTHER ORDERED that the petitioner's drug screens shall be decreased to 14 per year.
