On July 26, 2006, the Wisconsin Pharmacy Examining Board reviewed the previous order of the board liaison, dated July 20, 2006, terminating the stay of suspension of Roger G. Iverson. As reported by the department monitor to the board liaison for monitoring, the results of urine drug screening for Roger G. Iverson as provided within the board's *Final Decision and Order* ("*Order*") dated January 13, 1999, LS 9810131 PHM.; were as follows:

- 1. Screen positive for Benzodiazepines on 07-07-2006.
- 2. Screen positive for Benzodiazepines on 07-10-2006.

The Board reviewed the July 7 and 10, 2006, drug screen results for Roger G. Iverson. The Board concludes that the results violate paragraph 2a, of the *Order*. Also requested by Iverson was the granting of a "couple" of hours per week to be worked as a pharmacist in charge. Based on the foregoing:

IT IS HEREBY ORDERED: that pursuant to paragraph 8 of the *Order*, the stay of suspension for Roger G. Iverson, license number 8239, to practice pharmacy in the state of Wisconsin, is hereby TERMINATED and Roger G. Iverson is hereby SUSPENDED from the practice of pharmacy in the state of Wisconsin.

IT IS FURTHER ORDERED: that the request for the granting of hours worked as a pharmacist in charge, is denied.

IT IS FURTHER ORDERED: This order is effective upon the date of signing.
