On September 13, 2006, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by William Karwoski, R.Ph., for a three-month extension of the stay of suspension as provided within the board's *Final Decision and Order* (“*Order*”) dated March 10, 1999. Also requested was the further reduction or elimination of the requirement of urine drug screens required by the *Order*. (Currently 2 times per month.) The request was supported by his therapist. Also requested was that all limitations on Karwoski working as a pharmacist in charge be removed or that the *Order* be terminated in its entirety. The request was supported by his employer. Based upon the board's review:

IT IS HEREBY ORDERED that William Karwoski, R.Ph., is granted a three-month stay of the suspension of license #9334 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED that the request to further reduce or eliminate the urine drug screens required by the *Order*, is denied.

IT IS FURTHER ORDERED that the request to remove all limitations on working as a pharmacist in charge, is denied.

IT IS FURTHER ORDERED that the request to remove terminate the *Order*, is denied.
