On June 21 2006, the petitioner made his annual appearance before the Wisconsin Medical Examining Board and requested a three month stay of suspension and reductions in his drug screens and therapy requirement. Based upon the information of record showing that the petitioner is in compliance with his Board order and that his therapist supports the requested modifications, the Board makes the following order:

## <u>ORDER</u>

NOW, THEREFORE, IT IS ORDERED that the request for a three month stay of the suspension of the medical license of Benjamin W. Begley, M.D. (lic.# 20-29405) is hereby GRANTED.

IT IS FURTHER ORDERED that the petitioner's request for a reduction in his drug screens to one time per week and his therapy to one session every two weeks is hereby GRANTED.
