### PROCEDURAL HISTORY

On March 18, 2005, the Department of Regulation and Licensing issued an Order granting Respondent a limited license (#94-63194) to practice as a real estate salesperson in Wisconsin. The Order provided that failure by Ms. Cirilli to timely comply with the terms and conditions of the March 18, 2005 Order may result in the summary suspension of Ms. Cirilli's license or in the imposition of addition discipline. The Order also provided that upon verified documentation of a criminal conviction or probation violation subsequent to the Order, the department monitor may issue an order for revocation of Ms. Cirilli's limited real estate salesperson's license without further notice or hearing or other proceedings.

Ms. Cirilli has failed to file the required quarterly reports with the Department. Ms. Cirilli was convicted of Operating While under Influence (2<sup>nd</sup>) on or about February 15, 2007.

### **ORDER**

NOW, THEREFORE, IT IS HEREBY ORDERED that the real estate salesperson's license of Karlye E. Cirilli (#94-63194) is REVOKED.

This Order shall become effective upon the date of its signing.
