The Department of Regulation and Licensing on June 13, 2007, having considered the above captioned matter including the Statement of Reasons for Cancellation previously filed, a copy of which is attached hereto, makes the following Findings of Fact, Conclusions of Law, and Order:

### **FINDINGS OF FACT**

That applicant, Jacqueline Arnold, applied for a license or renewal of a license as a registered nurse and made payment of the required fee by personal check and that the personal check was not paid by the bank on which it was drawn as more specifically described in the Statement of Reasons for Cancellation attached hereto.

#### **CONCLUSIONS OF LAW**

That the license Nmber 152514 as a registered nurse issued to Jacqueline Arnold, applicant, is subject to cancellation for nonpayment of the check according to the provisions of ss. 20.905 and 440.23, Wis. Stats.

### **ORDER**

NOW, THEREFORE, IT IS HEREBY ORDERED that the license Nmber 152514 as a registered nurse issued to Jacqueline Arnold shall be and hereby is CANCELLED, effective immediately.
